Lambeth Music Service and In Harmony Lambeth wants to promote and celebrate its musical activity through recorded media. This material will contain images of children and young people that have participated in various activities/events, either as a learner, performer or as an audience member.

The interests and wellbeing of our musicians are paramount and Lambeth Music Service follows strict and legal Safeguarding protocols that ensure that all necessary steps are taken to protect children and young people at all times and from the inappropriate use of images.

Permission is sought from parents and carers of children who have music lessons through Lambeth Music Service for their child/ren to be recorded through visual and audio media. If consent is declined, Lambeth Music Service will contact parents and carers to discuss their reasons and decision as this may result in children being unable to participate in certain events.

Lambeth Music Service assures you that:

- We will never supply the full name of the child/children along with the image/ recording, unless written permission has been granted
- We will only use images of children in suitable dress
- All Lambeth Music Service photographers will be required to have an Enhanced DBS
- A photographer or film crew will never work unsupervised alongside children and young people
- Once permission is gained, Lambeth Music Service may use the Recorded Media for the following purposes:
 - 1. Using these sounds and images to celebrate and publicise the work of Lambeth Music Service or Lambeth Sounds Music Hub anywhere worldwide, and may retain archive copies of such recordings and photographs for use in future publicity for an unspecified time
 - 2. Photographs will be in the public domain and are therefore without restriction
 - 3. Lambeth Music Service reserves the right for use of the recorded media for selling/hiring/promoting and obtaining future funding
